CHANGE OF AGENDA ITEMS - GARY YOUNG

Gary Young spoke on the responsibilities of the officers on the Executive Board and the Institutional Trustees and the lodge operations. See included documents

TREASURER REPORT

Int. Treasurer Hanes went over the bank/credit union accounts deposits and expenditures. She stood for a question regarding saving on expenses - included life insurance premiums are less now due to changing from a life insurance policy that had a \$400,000 policy with a premium of \$495.50 and \$430.50) for the previous vice president and president respectively to a policy that is a \$36,000 policy; car insurance under Progressive for the year with no medical coverage for collision and comprehensive cost \$3,419.00 per year and now State Farm with full coverage, including medical is \$1,278.80 for 6 months/\$2,557.60 total for the year; and meals expenses for previous 6 months was \$2,057.24 (49 meals) and current last 3 months was \$142.54.

CORRESPONDANCE

Secretary DeMary mentioned assaults needing to be confirmed but received approximately 16 reports.

The National Board sent out communication regarding the yearly Per Capita Tax that is due before or by November 1, 2024.

OFFICER REPORTS

Treasurer Hanes reported that prior to her taking office, someone had deleted QuickBooks from January to May of 2024 and it has been salvaged. All accounts have been reconciled and are current.

REPORT OF CAR PURCHASES
