NEW BUSINESS

Kolton Neuhaus (NRC), Micala Wessel (NSP), Donald Hathaway (RTC) and Lucas Fields (CCC-O) were sworn in as Trustees by President Wilson.

Discuss and Voted on PAS Fund adjustment – Int. Treasurer motioned to reduce the Pac Fund percentage of dues from 3.5% to 1.5%. Trustee Holmes 2nd. The current balance as of September 2024 is \$27,097.54. Motion carried with a vote of unanimous ayes (12). Trustees Hathaway and Kolton Neuhaus left the meeting prior to vote.

Discuss and Vote on Treasurer and Secretary salary/stipend increase – VP Clowes motioned to increase the salary of the Treasurer and Secretary to \$750/month, President Wilson 2nd. Trustee Osienger motioned an amendment to adjust the monthly salary to \$1,000.00. VP Clowes 2nd. Motion carried with a vote of unanimous ayes (10) except for Int. Treasurer Hanes and Secretary DeMary who abstained.

Discuss and vote on training – VP Clowes motioned to have proper allocation of no more than \$5,000.00 for training (in grievances/SOC appeals/complaints as needed) Trustees and Stewards on an ongoing basis. Secretary DeMary 2nd. Motion carried with a vote of unanimous ayes (12).

Discuss and vote on attendance of Leadership Matters (National Training in Nashville, February 2025 – Secretary DeMary motioned to send 3 board members. Treasurer Hanes 2^{nd} . Treasurer Hanes motioned an amendment to include 4 members to attend with a maximum of \$5,000 cost. Secretary DeMary 2^{nd} . Motion carried with a vote of unanimous ayes (12).
